REQUIREMENTS

- **Applicant must be a resident of the Town of Huntington.**
- Applicant must be a high school senior at time of application.
- Applicant must attend college or a vocational/trade school within the scholastic year following graduation.
- **Applicant must demonstrate financial need (total household income cannot exceed 80% of median HUD 2013 income limits chart). Applicant must provide documentation proving financial eligibility (attach copy of completed 2012 income tax return or alternate documents establishing financial eligibility). This information is mandatory.**
- Applicant must provide a sealed official high school transcript.
- Applicant must submit a letter of recommendation from a member of their high school community (i.e. principal, guidance counselor, teacher, school psychologist, coach, ...).
- Applicant must provide letters of reference from two (2) unrelated persons he/she has known for at least one year.
- Applicant should demonstrate community service, family responsibilities, and/or extracurricular activities performed during his/her high school career.
- The scholarship funds may only be utilized to pay tuition, room and board, books, or a school meal plan. Said funds may only be payable directly to the learning institution.
- Application (2 pages plus 500 word essay) must be typed or neatly handwritten and filled out in its entirety.
